The financial statements and audit report are reviewed at a regularly scheduled meeting of the board of directors and approval is recorded in the meeting minutes. Written proposals from independent accounting firms for completion of financial statements/audits are reviewed and approved by the board of directors prior to their selection, and approval is recorded in the board of directors meeting minutes.
